





# PROJECT MODELS



### **Client Assistance**

Client assistance projects provide legal services directly to clients with the support of a Supervising Lawyer. They often involve helping clients with applications, legal forms and the process for changing or applying for identification.

### **Public Legal Education**

JNIVERSITY OF

Public legal education (PLE) projects provide students the opportunity to develop and deliver legal education materials (e.g., FAQs, info sheets, etc.), workshops, and seminars to people and communities facing barriers to justice. These projects involve sharing legal information and resources with clients and communities. They can take the form of plainlanguage brochures, presentations, web-based resources or infographics.

### Legal Research and Writing

Legal research and writing (LRW) projects include the reviewing and monitoring of pending legislation, writing legal memos or analysing current policy questions, and writing for media such as newsletters or blogs.

# Student Volunteer FAQs

#### What will I be doing as a PBSC volunteer?

PBSC volunteers provide legal information to the Windsor community in a variety of ways. If placed in a client assistance project, your time will be spent working with clients face to face to assist them access legal information, government identification, or drafting wills. If placed in a legal research and writing project, you will be researching legal information and providing it in a plain and easy to follow deliverable (brochure, memo, etc.). If placed in a public legal education seminar project, you will also be researching legal informative individuals.

#### How do I apply for PBSC?

Complete the online application before <u>Friday</u>, <u>September 22nd at 5:00 p.m.</u> (applications open Monday, September 18th). Although we would love to give each student a PBSC placement, placements are LIMITED, Therefore, please be sure to take your time and complete your application in full! Due to the number of applicants, we do not hold interviews, this means that your application is the only item we use to place you in a project. Be sure to include WHY you would be a great fit for the project(s) you are interested in!

#### Can 1Ls apply for a PBSC placement?

Yes! Any student who is enrolled in the University of Windsor Faculty of Law may apply for a PBSC project. This includes 1L students who are interested in volunteering with PBSC!

#### What is the time committment for a PBSC placement?

All PBSC projects are designed for 3-5 hours of volunteer hours per week. However, every project will have a slightly different time requirement and schedule. PBSC runs from October to March with a break in December for exams. Our PBSC Program Coordinators are also especially sensitive to important deadlines and busy periods during the year, particularly for the 1L class.

#### Are projects remote or in person?

Each PBSC project meets differently. Most research work may be conducted virtually on the volunteer's own time. While other projects, such as the clinics, will meet in person at the partner organization a predetermined time throughout the semester.







### **#1: Trans ID Clinic**

**Organization:** Trans Wellness Ontario (TWO)

**Description:** The Trans ID Clinic provides free legal information, form-filling services and referrals in a learning space that strives to be trans-positive, non-judgemental, anti-oppressive and inclusive.

Students will also create a deliverable in the form of a brochure outlining the steps of obtaining a will.

The second component of the project is a public legal education seminar where student volunteers will present their findings to students.
